MANDATORY REQUIREMENTS  2) Certificate of Distributorship/Manufacturer's Authorization	Since Lot 01 has two (2) items, the Power Quality Analyzer (PQA) and the AC/DC Clamp Meter, can we provide only one (1) Certificate of Distributorship for the PQA only?	Yes, you may provide only One (1) Certificate of Distributorship if it is for the PQA being the item having the higher value. But it is best if the bidders can provide certificate of distributorship for each item.
2.	II. TERMS OF REFERENCE D. DELIVERY REQUIREMENTS  Deliveries shall be made to Ibaan Electric Corporation, Metro-Rei Business Park, Brgy. Palindan, Ibaan, Batangas. Delivery of items should be within thirty (30) calendar days from receipt of the Notice to Proceed (NTP).	In terms of delivery requirements, can we extend the stated delivery time up to five (5) to six (6) weeks?	The Bidders are allowed to extend the delivery requirement up to the maximum period until April 4, 2025.

Since there were no Ampere requirements stated on the Terms of Reference, the Committee requires the 3000A or 6000A as the maximum range for the flex probe with the length of 24 inches or 36 inches.

## 7. V. PERFORMANCE SECURITY
